SPECIAL EMERGENCY AMBULANCE SERVICE FEE ORDINANCE

AMENDED: _____

SECTION ONE—LEGISLATIVE AUTHORITY AND PURPOSE:

Under the authority of Chapter 7, COUNTY COMMISSIONS AND OFFICERS, Article 15, EMERGENCY AMBULANCE SERVICE ACT OF 1975, Section 17, IMPOSITION AND COLLECTION OF SPECIAL EMERGENCY AMBULANCE SERVICE FEE BY COUNTY COMMISSION, of the West Virginia Code, as amended.

This Ordinance is enacted for the purpose of establishing and maintaining an adequate emergency ambulance system within the geographic boundaries of Hardy County, West Virginia. An adequate emergency ambulance system is necessary to promote the health and welfare of the citizens of Hardy County. Emergency ambulance service is a public purpose and a responsibility of government for which public money may be spent.

SECTION TWO—DEFINITIONS:

Living Unit – Means any place of residence, occupied or unoccupied, as classified by the records of the Hardy County Assessor including, but not limited to, residential homes, vacation and secondary homes, mobile homes, seasonal camps, hunting, fishing and recreational camps, duplexes, Airbnb, VRBO, condominiums, apartments, personal care facilities, and rental units. For structures which contain multiple addressable units, such as apartments, duplexes, and personal care facilities, each addressable unit shall be deemed to be a separate billable unit. Structures that may not have water, electric, or septic still qualify as a living unit for the purpose of this ordinance.

Business Unit – Means any place occupied for the purpose of operating any type of business activity and not for a purpose listed under Living Unit, including public utilities.

Employee – Means any part-time or full-time employee regardless of how many hours he/she may work a week. However, any person who is employed through a school-based internship or for educational purposes shall not be considered an employee for purposes of this ordinance.

Owner – Means the person or persons listed in the records of the Hardy County Assessor possessing exclusive rights and control of a property, as of July 1st of each year.

Occupant – Means the now-owning resident of a living unit defined as above.

Resident User – Means any bona fide owner or occupant of a living unit within the geographic boundaries of Hardy County.

Nonresident User – Means any individual who does not qualify as a resident user.

Homestead Exemption – Means any full-time resident on record with the Hardy County Assessor's office as "Homestead Exempt."

Delinquent User – Means any resident or non-resident whose Emergency Ambulance Service Fee has not been paid for any period.

User – Means any person to whom emergency ambulance service is made available.

Emergency Ambulance System – Means any emergency ambulance service provided pursuant to this ordinance.

Business Located At Same Location As Residence – Means any person owning a business located within their living unit and performing the duties required to maintain said business within their living unit.

Erroneous Billing – Means an invoice that was sent to the wrong person in error.

Fiscal Year – July 1st to June 30th.

No Living Unit – Means no living unit on property or the living unit has been removed, torn down, or lost due to acts of nature since the last billing cycle.

Multiple Living Units For Owner’s Use Only – Means any resident who has paid a fee for their primary living unit and owns multiple living units within Hardy County that are vacant and only used by the owner of the property on record in Hardy County Assessor records. This does not apply to any additional living units that are rented, leased, temporarily vacant, or being occupied by someone full-time for any reason.

Unlivable – Means any living unit classifies as Unlivable or Unsound in the Hardy County Assessor’s records.

Owner Living In Nursing Home Or Assisted Living Unit – Means owner has been removed from their living unit and placed in a nursing home or assisted living unit. The living unit must not have any occupants living in the unit, and a confirmation letter from the nursing home or assisted living unit is required.

Government Agency – Means an agency described as government in the West Virginia Constitution or West Virginia Code.

Approved Annual Budget Estimate – The final budget formally approved and adopted by the Hardy County Emergency Ambulance Authority Board of Directors and the Hardy County Commission.

Basic Life Support – A basic level of services including:

- Head-to-toe assessment;
- Vital sign monitoring such as blood pressure, pulse rate and quality, and respiratory rate and quality;
- Oxygen delivery when needed;
- Wound care and splinting;
- Cardiopulmonary Resuscitation (CPR); and
- Minor non-life-threatening care with transport to the hospital.

Advanced Life Support – An advanced level of services including all basic level services as well as:

- Heart rhythm monitoring;
- 12-Lead Electrocardiogram (BCG);
- Provision of alternate breathing intervention if patient is not capable of breathing on their own;
- Intravenous fluid access; and
- Administration of multiple drugs for stabilization of life threatening heart problems, pain management, shock management, respiratory problems, seizure disorders, and many more illnesses and injuries.

Special Emergency Ambulance Service Fee – Means a specified uniform fee charged to each living unit and each business unit imposed by the Hardy County Commission through this Ordinance and collected from users to which ambulance service is made available.

Nearest Certified Medical Facility – Limited to any hospital within the boundaries of Hardy County and hospitals in the following locations or closer: Petersburg, WV; Harrisonburg, VA; Romney, WV; and Winchester, VA.

Emergency Ambulance Rate – Means the individual transport charges as established and promulgated by the Hardy County Ambulance Authority and its subcontractors, subject to the approval of the Hardy County Commission. These rates shall be applied to any and all users of emergency ambulance transport service provided by the Hardy County Ambulance Authority.

Emergency Inter-Agency And Non-Emergency Transport Charges – Means the individual transport charges established and promulgated by the Hardy County Ambulance Authority and its subcontractors for routine transports and secondary transport from one medical care facility to another. Such transport charges shall be applied to all users of such transport service, as defined to-wit; resident, non-resident, and delinquent resident.

SECTION THREE—COVERAGE:

There are three broad groups of persons who are covered under this Ordinance. All groups, as defined by this County Ordinance, have the responsibility to pay on time. Failure to obtain the billing notice, billing reminder, or late notice in no way exempts one from the responsibility of the original fee and late fees. The first group consists of those owners of living unit(s) in the County. These persons are liable for payment of the Special Emergency Ambulance Service Fee as defined and described above. The second group is a business unit which operates a business in Hardy County. The third group consists of those persons, resident or not, who avail themselves of the transport services.

SECTION FOUR—HCEAA BUDGET DEVELOPMENT:

The Hardy County Emergency Ambulance Authority shall hold an annual public hearing for the purpose of receiving public comment pertaining to the operations of the emergency ambulance system within Hardy County. This public hearing shall be advertised as a Class II legal advertisement in all local newspapers within Hardy County.

The required public hearing shall be held in conjunction with the regular January Board of Directors meeting in order to provide the Hardy County Emergency Ambulance Authority sufficient time to consider any improvements or changes in service and to account for said changes when submitting the annual budget request required below.

No later than one hundred (100) days prior to the beginning of the Hardy County Fiscal Year (July 1st through June 30th) each agency providing emergency ambulance service in Hardy County shall prepare a budget for the total estimated cost, consistent with available funding, for providing emergency ambulance service within the geographical boundaries of the county for the Fiscal Year commencing on the following July 1st and, upon adoption by the Hardy County Emergency Ambulance Authority Board of Directors, present said estimated budget to the Hardy County Commission for review and approval.

SECTION FIVE—ESTABLISHMENT OF SPECIAL EMERGENCY AMBULANCE SERVICE FEE:

Each Special Emergency Ambulance Service Fee imposed under this Ordinance shall be for the Hardy County Fiscal Year, July 1st to June 30th of the prior year. The Emergency

Ambulance Service Fee established by this Ordinance shall be one hundred twenty dollars (\$120.00) per living unit per Fiscal Year. Payments may be made twice a year on September 1st and March 1st. Those persons qualifying for Homestead Exemption tax status, shall have the established fee of seventy-five dollars (\$75.00) for that unit which said Homestead Exemption applies on their tax ticket.

The Emergency Ambulance Service Fee established by this Ordinance for business units shall be based upon the number of employees each business employs as set forth below:

A minimum fee of one hundred twenty dollars (\$120.00) shall be billed and payable for each business. (Appendix A)

Landlords are responsible for the payment of any tenant living in a living unit. However, a landlord is not responsible for the ambulance fee if their tenant has already paid the fee for that living unit.

SECTION SIX—FEE EXEMPTIONS OR MODIFICATIONS:

If an owner believes he/she is erroneously charged an ambulance service fee, the Hardy County Commission shall provide, upon the resident's request, an erroneous billing form. The form shall be filled out by the resident, signed, and returned to the Hardy County Commission no later than thirty (30) days from the date of the billing. The Hardy County Commission shall, within a reasonable time, cause to be investigated any request for exoneration.

If good cause of an erroneous billing is found by the Hardy County Commission, said Commission shall modify or change any or all imposed charges, and shall notify the property owner in writing of its actions. If the Hardy County Commission does not modify or change the fee imposed as requested by the property owner, an appeal may be filed, in pursuance to this article, with the Circuit Court of Hardy County.

There shall be exempted from the provisions of this ordinance any incorporated area within Hardy County, provided that, within thirty (30) days of the effective date of such incorporation, such area files, with the Authority and the Hardy County Commission, a written request for such exemption and an affidavit stating that it will provide ambulance services substantially similar to those set forth herein to its residents at its own expense.

Ambulance services, fire departments, and other governmental agencies are exempt from paying any fee imposed herein.

Other reasons for exemption request:

- Business located at same location as residence;
- Erroneous billing;
- Multiple living units for owner use only;
- No living unit;
- Unlivable structure;
- Owner living in nursing home or assisted living facility; and
- Government agency.

SECTION SEVEN—BILLING AND COLLECTION PROCEDURES:

A. Special Emergency Ambulance Service Fees:

Upon completion of the estimated budget by the Hardy County Emergency Ambulance Authority, the Manager of the Ambulance Authority shall request the Assessor to provide the County Commission with a list of all residential “living units” and businesses to be utilized as the database for billing the Special Emergency Ambulance Service Fees for the Fiscal Year commencing the following July 1st. Each business unit shall provide a form and shall list the number of employees so employed and shall pay the fee set forth in Section Five. Each living unit on that list shall have an account established in the name of the owner(s) of that living unit and a bill in the amount of the Emergency Ambulance Service Fee as defined in Section Five of this Ordinance shall be delivered to that living unit by U.S. Postal Service on or after July 15th of the Fiscal Year.

The Emergency Ambulance Service Fee accounts established under this Ordinance shall be paid in full no later than March 31st of the Fiscal Year for which billed. On April 3rd of each year, delinquent invoices shall be sent to all current year unpaid accounts, with a thirty dollar (\$30.00) late fee added as a status reminder.

B. Delinquent Accounts:

Accounts delinquent on or after July 1st, after they became due and payable, shall be reviewed by the Hardy County Commission. The County Commission, at its sole discretion, may collect unpaid fees through civil action filed in a court of competent jurisdiction or a collection agency. Such suit need not be brought in the same fiscal year the fee was filed. In any suit for collection of delinquent fee(s), the Hardy County Commission is authorized to recover its reasonable costs of collection, including court costs, attorney’s fees, service costs, and statutory interest.

C. Transport Charges:

Ambulance transport rates per call for all categories of users shall be in amounts recommended by the Hardy County Emergency Ambulance Authority Board of Directors, and approved by the Hardy County Commission. Revisions to transport rates will be recommended to the Hardy County Commission from time-to-time as the Board of Directors sees fit. Transport rates will include charges for provision of Life Support, Basic or Advanced, oxygen, and mileage, and will be billed to users in accordance with the particular services rendered. Charges for individual transports shall be processed by the agencies as appropriate with due allowance for insurance coverage, if any. Any accounts becoming delinquent shall be submitted to the appropriate collection agency as engaged by the Authority.

SECTION EIGHT—MANAGEMENT OF REVENUES:

All revenues received in accordance with this Ordinance shall be deposited into a special fund known as the Special Emergency Ambulance Service Fee. These funds shall be used to pay reasonable and necessary expenses actually incurred including personnel and the cost of buildings and equipment used in providing emergency ambulance service to residents of the county and others that might require such services. Such funds may be used to pay for, in whole or in part, the establishment, maintenance, and operation of the Authority. Funds not expended in a given Fiscal Year will be maintained in the above Fund and may be used in subsequent Fiscal Years as necessary.

SECTION NINE—DISTRIBUTION OF ASSETS FOLLOWING A DISSOLUTION OF AN EMERGENCY AMBULANCE SYSTEM

Upon the dissolution of any Emergency Ambulance System which receives funding pursuant to this Ordinance, assets shall be distributed to the Hardy County Commission to be used for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

SECTION TEN—AMENDMENTS AND EXECUTION:

This Ordinance may, from time-to-time, be amended by a majority of the members of the County Commission as they deem necessary and appropriate.

If a court of competent jurisdiction declares any provision of this Ordinance to be invalid or ineffective in whole or in part, the effect of such decisions shall be limited to those provisions which are expressly stated in the decision to be invalid or ineffective, and all other provisions of this Ordinance shall continue to be separately and fully effective.
