IN RE: COMPREHENSIVE PLAN AND ZONING ORDINANCE FOR HARDY COUNTY:

This day came the Hardy County Planning Commission, by Cecil Clark, its Chairman, and tendered to the Court a Comprehensive Plan and Zoning Ordinance entitled "Hardy County Zoning Ordinance" consisting of one mimeographed volume containing 23 pages. It appears to this Court that the said Hardy County Planning Commission heretofore submitted to this Court a tentative report of the proposed Zoning Ordinance, with explanatory maps, and that the same were considered by this Court and returned by it, with suggestions and recommendations, to the Planning Commission for its final report, and that the final report of said Commission was heretofore submitted to this Court and that this Court did afford all interested persons an opportunity to be heard with reference to the final report at public hearings held at the County Courthouse at Moorefield, the High School at Mathias, the War Memorial Building at Wardensville and the Rig School House at Rig, on October 12, October 17, October 18 and October 19, 1972, respectively, and that notice thereof was caused by this Court to be published in the Moorefield Examiner, a newspaper published and of general circulation in Hardy County, as required by law, such notices having set forth therein the dates, times and places of the hearings, and that the report contains a Comprehensive Zoning Ordinance for the County of Hardy, and that written objections to the final report filed with the Clerk of this Court at or before the hearings would be heard, and said notices were published within a period of fourteen consecutive days next preceding the dates set for the hearings, and that during the period between the date of the first publication of said notices and the date of the respective hearings, the final report shall be on file in the office of the Planning Commission and in the office of the Clerk of this Court for public examination, and it is further ordered that said final report was so on file in the said offices of the Planning Commission and the Clerk of this Court.

It appears to the Court, and is now ordered, that the Comprehensive Plan and Hardy County Zoning Ordinance now before this Court for consideration is the same as that heretofore acted upon by this Court and by the Hardy County Planning Commission, and copies of which were duly filed as aforesaid in the offices of the Planning Commission and in the office of the Clerk of this Court for public examination, and that the public hearings thereon have been completed and that this Court shall now proceed to the consideration of the said Ordinance.

Thereupon, on motion duly made and seconded, and approved, it is hereby ordered that pursuant to the provisions of Chapter 8, Article 24, of the Code of West Virginia, the Comprehensive Plan and the Ordinance known as the "Hardy County Zoning Ordinance", as submitted is hereby adopted as the Comprehensive Plan and Zoning Ordinance for Hardy County, West Virginia, to take effect March 1, 1972
